EVENTS

European Public Health Conference

8-10 November 2012, Malta

Roma health issues had a high profile at the 5th Annual European Public Health Conference, organized by the European Public Health Association (EUPHA). Under the heading "Healthy Europe, healthy Roma", the Open Society Foundations organized and supported a number of contributions to the conference, including presentations on vaccination programmes, mental health and health status in Roma settlements, posters on health research and a workshop highlighting systemic barriers faced by Roma in access to health care. Recognizing that Roma health demands more attention and further study, EUPHA's Section on Ethnic Minority and Migrant Health decided to allocate a seat on its steering committee to an academic or researcher working on Roma health issues.

Roma health a focus at European Public Health Conference

Training on ensuring greater equity in health policies

7-8 November 2012, Belgrade, Serbia

A training course on how to reorient strategies, programmes and activities related to Millennium Development Goals 4 and 5 towards greater health equity (with an explicit but not exclusive focus on Roma) was organized by WHO/Europe in collaboration with the WHO Collaborating Centre on Social Inclusion and Health at the University of Alicante and the Spanish Ministry of Health, Social Services and Equality. Participating experts from four pilot countries for implementation of the approach (Bulgaria, Montenegro, Serbia and the former Yugoslav Republic of Macedonia), Albania, Bosnia and Herzegovina, the United Nations Population Fund (UNFPA) and the United Nations Children's Fund (UNICEF) were trained to act as trainers on health equity and social determinants of health approaches to policy-making. The course was based on a new guide developed by the Spanish Ministry of Health, Social Services and Equality:

Consultation meeting on role of the European Alliance of Cities and Regions for Roma Inclusion 25 September 2012, Strasbourg, France

Representatives of European cities and regions, European Union (EU) institutions, international Roma networks and nongovernmental organizations (NGOs) gathered on 25 September 2012 at the Council of Europe headquarters in Strasbourg to discuss the future role and activities of the European Alliance of Cities and Regions for Roma Inclusion. The expectations, needs and priorities expressed at the consultation meeting, as well as available resources, will be considered by the Alliance in drawing up its programme of forthcoming activities.

UNFPA workshop on best practices in addressing health issues among Roma youth

10-11 September 2012, Istanbul, Turkey

Representatives of ERGO Network and TernYpe, the international Roma youth network, participated in an advocacy workshop on Roma youth health issues hosted by UNFPA's Regional Office for eastern Europe and central Asia (UNFPA EECARO). The meeting aimed to strengthen partnerships among Roma organizations, NGOs and UNFPA, increase understanding of Roma youth health needs and draw attention to ways in which existing systems fail to meet those needs.

Innovative strategies for addressing sexual reproductive health issues amongst Roma youth and strengthening advocacy for health issues were proposed and shared by participants. The outcomes of this workshop will be incorporated in a wider advocacy strategy to be implemented in 2013.

<u>European Roma and Travellers Forum (ERTF) Plenary Assembly adopts recommendations on Roma in Europe</u>

6-7 September 2012, Strasbourg, France

Recommendations submitted to the Council of Europe (CoE) and the EU Member States and a resolution urging the Committee of Ministers and the European Council to adopt a European Roma Rights Charter were unanimously adopted at the meeting of the Plenary Assembly of the European Roma and Travellers Forum.

RESOURCES AND REPORTS

WHO opens new Collaborating Centre on Social Inclusion and Health in Spain

WHO has designated the Interuniversity Institute of Social Development and Peace, University of Alicante, Spain, as a WHO Collaborating Centre on Social Inclusion and Health. This new centre will contribute to the design and implementation of the WHO/Europe training programme on Roma health, including through the co-production of resource packages and co-design of training methodologies.

Successful UNDP social development model adopted by Roma communities in Hungary

Resource centres for social development are local development institutions established by the United Nations Development Programme (UNDP) in various locations in Hungary to promote inclusion of people living in deep poverty and segregation. They take an integrated approach based on the four pillars of the Roma inclusion strategy, which includes the involvement of the target group in the development process. The effectiveness of resource centres for social development as a development tool has been demonstrated recently by their spontaneous spreading in Roma communities: in the past six months five Roma communities have asked the Abaúj Resource Centre for Social Development to help them develop their own resource centres based on this model

Discrimination in the European Union in 2012: special issue of Eurobarometer

This November 2012 issue of the Eurobarometer reports the results of a survey on discrimination coordinated by the Directorate-General Communication. It reveals large differences between countries, both in terms of social diversity and the acceptance of diversity in the public sphere. Special attention is devoted to the perceived effectiveness of national efforts to integrate the Roma population and on perceptions of the Roma situation in society.

Primary care for minority patients: position paper of EFPC Working Group

As an introduction to this subject for its members, and as a basis for further planning of documentation, information exchange, research and other activities, the European Forum for Primary Care (EFPC) prepared a position paper on primary care for minority patients. This paper was used as a guide for discussion during the first workshop of the Working Group on minority patients, which took place on 16 September 2012.

Use of EU Structural Funds for Roma health: fact sheets on Bulgaria, Romania and Slovakia

The Roma Health Project of the Open Society Foundations has produced fact sheets on the allocation and implementation of European Union funds in Bulgaria, Romania and Slovakia. Mapping the situation in these countries in 2011, the fact sheets include a list of opportunities and recommendations for increasing the utilization of available EU funds for advancing Roma health.

EQUI-HEALTH: new project to foster the equitable provision of health for vulnerable groups

EQUI-HEALTH is an International Organization for Migration (IOM) project co-funded by the European Commission's health programme (under the work plan for 2012). EQUI-HEALTH aims to improve the access and appropriateness of health care services, health promotion and prevention to meet the needs of migrants,

the Roma and other vulnerable ethnic minority groups, including irregular/illegal migrants. The project will start in February 2013 with a duration of 36 months.

Roma Health Report to gauge progress in the European Union

The Executive Agency for Health and Consumers in cooperation with the Directorate-General for Health and Consumers (DG SANCO) has contracted Matrix Insight (United Kingdom) to prepare the Roma Health Report, which is expected to be completed in early 2014. The project's objective is to provide scientific background input for planning of the Commission's actions in reducing the health gap between Roma and the rest of countries' populations. Special features of the report will be an assessment of the health status and health-related lifestyle attributes of Roma populations in various countries and a report on Member States' data collection activities.

UNFPA and WHO/Europe strengthen strategic collaboration

On 3 December 2012, Werner Haug, Regional Director of UNFPA EECARO, met with Zsuzsanna Jakab, Regional Director of WHO/Europe, to discuss opportunities to strengthen the organizations' ongoing collaboration, which has spanned 25 years and a range of issues, including Roma health. Stepped up information sharing and greater technical, strategic and policy collaboration between the two agencies, as envisioned by the two directors, will enhance their efforts to support public health in the eastern European and central Asian Member States of the WHO European Region.
