EFNNMA Position Statement on agenda 5(c) item "Towards a sustainable health workforce in the WHO European Region: framework for action"

67th session of the WHO Regional Committee for Europe, Budapest, 11-14 September 2017

The European Forum of National Nursing and Midwifery Associations (EFNNMA) warmly congratulates the WHO Regional Office for Europe on the development of the European framework for action towards a sustainable health workforce aimed to accelerate progress towards achieving the population health objectives of Health 2020, and the longer-term health goals for Member States in the European Region, by sustaining a transformed and effective health workers within strengthened health systems.

Representing the largest group of health professionals in every Member State, EFNNMA would like to emphasise that nurses and midwives have a 'triple impact' - not only on health outcomes and the quality of health services, but also on gender equality and economic growth. Nurses and midwives are in the best position to make a contribution to health literacy and chronic care, health promotion and quality of life. We play a crucial role in improving access to health care services, strengthening primary health care, improving quality of life and increasing life expectancy.

Investing in nursing and midwifery workforces, liberating and developing our professions to maximize our potential is arguably the one of the biggest workforce challenges facing the Region. EFNNMA hopes that the adoption of European Framework for action will fuel the implementation of another important WHO document "European strategic directions for strengthening nursing and midwifery towards Health 2020 goals" which define the areas which require special attention, namely: effective workforce planning and transforming education, evidence-based practice, and a positive working environment.
