The time-frame for this draft resolution on the Declaration of the Sixth Ministerial Conference on Environment and Health takes into account the fact that the Declaration establishes the European Environment and Health Process as the platform for implementation of the Sustainable Development Goals (SDGs) and the SDG targets relevant to environment and health.

The estimated cost for 2016–2017 and 2018–2019 is included in the relevant PB; however, only 64% of the funding is currently available. It will not be possible to mobilize funds to implement the full 2016–2017 PB by the end of 2017. A resource mobilization strategy for this area of work is under development for the 2018–2019 biennium.
