Figure 1: Top 10 countries with Measles Cases in European Region, 2017* (data as of 02 February 2018)

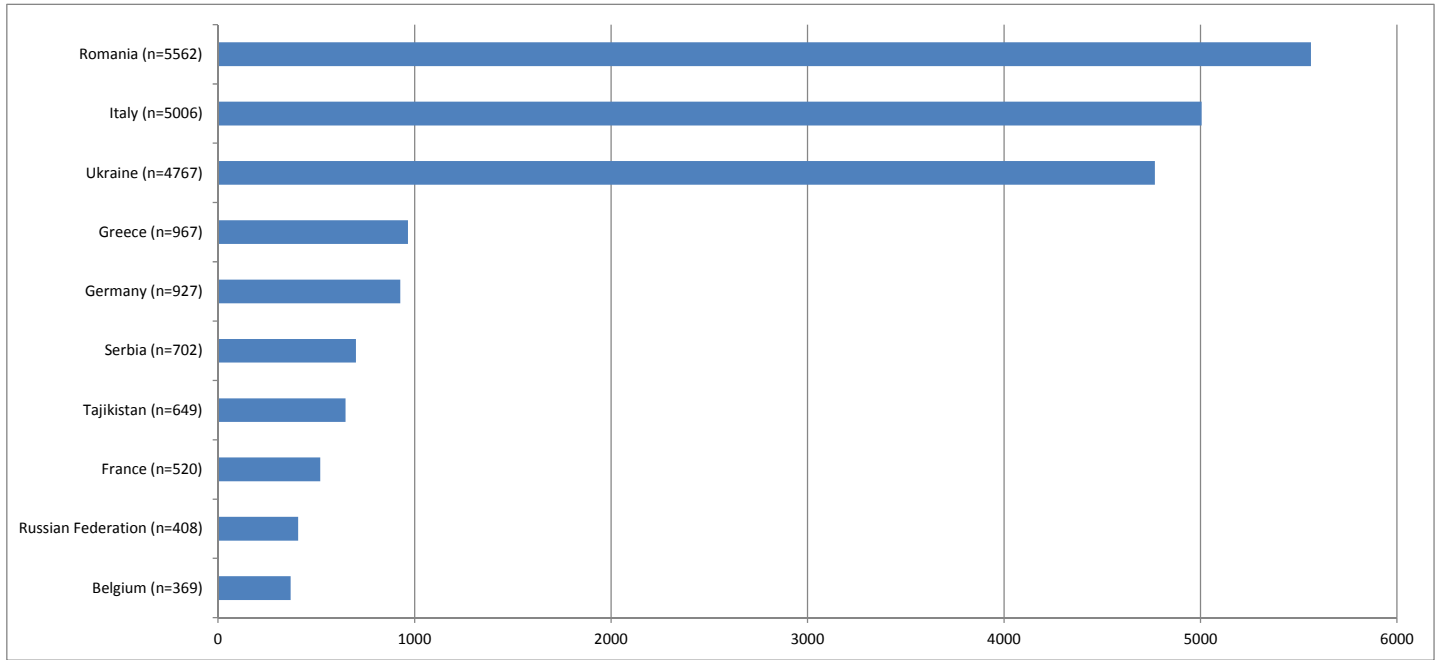


Figure 2: Age and vaccination status of measles cases in Romania, 2016 — 2017* (data as of 02 February 2018)

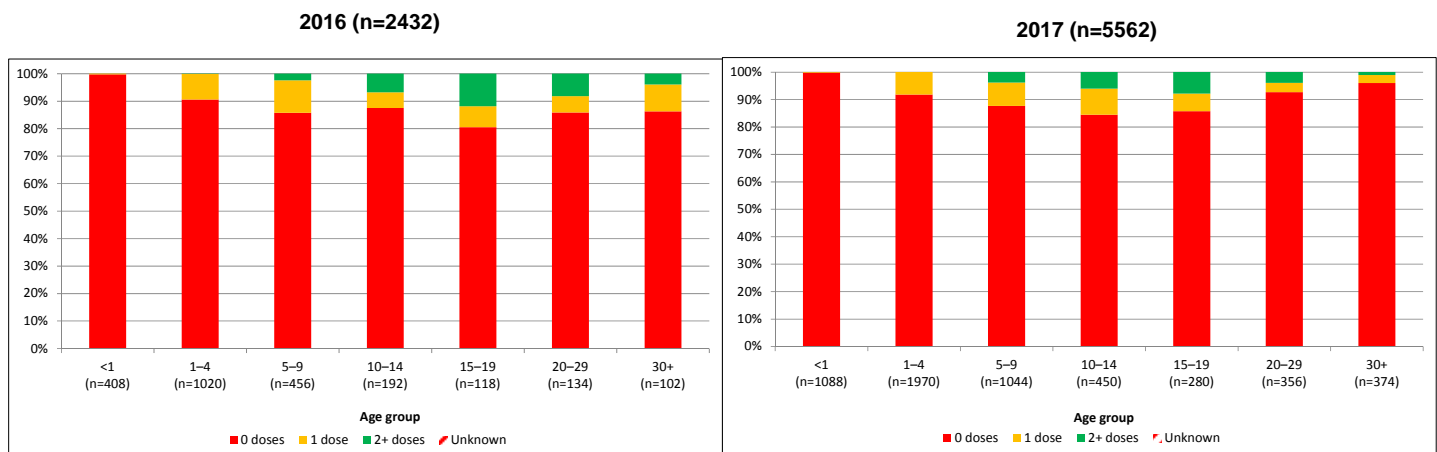
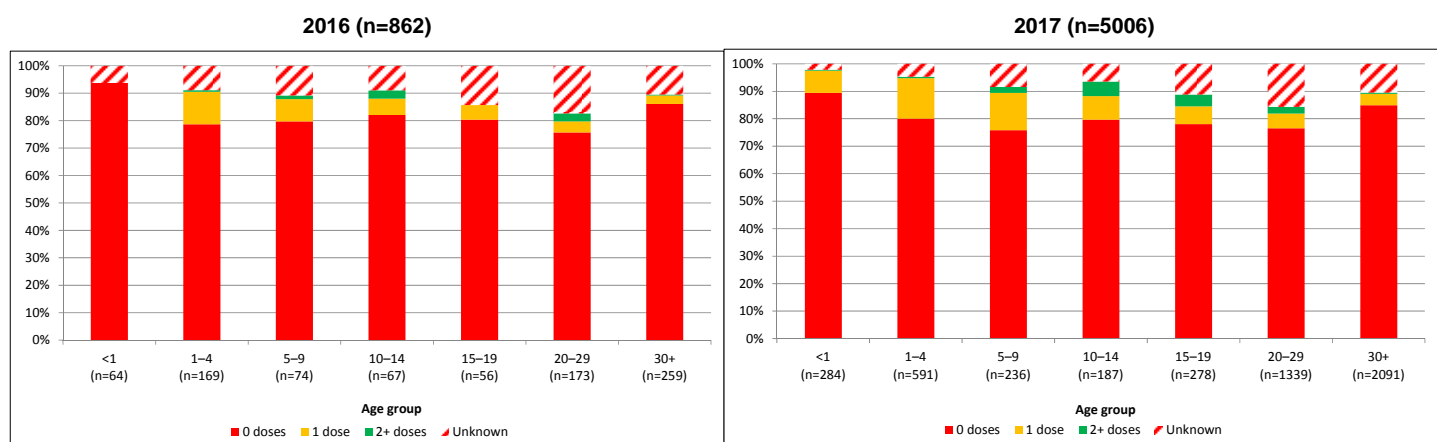


Figure 3: Age and vaccination status of measles cases in Italy, 2016 — 2017* (data as of 02 February 2018)
