## Financial and administrative implications for the Secretariat of the draft Regional Committee resolution on advancing public health for sustainable development in the **WHO European Region**

**Resolution:** Advancing public health for sustainable development in the WHO European Region

#### A. Link to the programme budget

1. Category(ies), outcome(s) and output(s) in the Programme budget 2018–2019 to which this draft resolution would contribute if adopted.

The main outcomes and outputs, to which this draft resolution would contribute, are indicated below. - 4.1.1 Improved country governance capacity to formulate, implement and review comprehensive national health policies, strategies and plans (including multisectoral action, a "Health in All Policies" approach and equity policies)
- 4.1.2 Improved national health financing strategies aimed at moving towards universal health coverage
- 4.2.1 Equitable integrated, people-centred service delivery systems in place in countries and public health approaches strengthened
- 4.2.2 Health workforce strategies oriented towards universal health coverage implemented in countries
