European Region Remains Free of Polio

The European Regional Certification Commission (RCC) met at the WHO Regional Office for Europe, Copenhagen from 13-15 June 2007 to review the status of polio eradication in the Region. The meeting was attended by seven members of the RCC, the WHO secretariat and representatives of the polio programmes of selected countries. Of the 53 Member States in the Region, 50 (94%) submitted reports on their 2006 activities. The RCC reviewed the updates and heard presentations on the Regional Polio Laboratory Network and laboratory containment of wild polioviruses. Representatives from the Global Polio Eradication Initiative and the Eastern Mediterranean Regional Certification Commission reported on the status of global and regional polio eradication efforts, respectively. Representatives of Azerbaijan, Bosnia and Herzegovina, Greece, Netherlands, Tajikistan and Turkey gave special presentations on their national polio eradication programmes. WHO Regional Office for Europe (EURO) staff reported on progress towards a strategic plan for sustaining the polio-free status of the Region.

After reviewing all available country reports and supplemental information provided by the Secretariat, the RCC concluded that the Region remains free of wild poliovirus transmission five years following certification. The RCC was greatly concerned that, in spite of progress achieved globally, the risk of importation of wild poliovirus into the European Region remains very high and that following an importation, wild poliovirus could spread in geographical areas and/or subpopulations with low immunization coverage. The RCC wishes to reemphasize the importance of all countries within the Region maintaining uniformly high routine immunization coverage and high-quality surveillance for polio as well as other vaccine-preventable diseases. The RCC emphasized that the current global situation calls for the strong political commitment of all WHO Member States to stop poliovirus transmission and provide sustained financial support for the global polio eradication programme.

The RCC made the following general recommendations regarding the polio eradication initiative in the Region:

- 1. The RCC strongly encourages all countries to conduct annual National Certification Commission (NCC) meetings as a demonstration of national commitment to sustain polio-free status.
- 2. The European RCC requests that the Global Certification Commission establish clear terms of reference for NCCs in the post certification phase.
- 3. While AFP remains the gold standard for polio surveillance, the RCC endorses the use of enterovirus surveillance (primarily aseptic meningitis surveillance) as an adjunct to AFP, emphasizing the timely collection and analysis of stool specimens.
- 4. The RCC recommends Member States assure adequate financial support for continuing high-quality, laboratory-based national surveillance systems.
- 5. After reviewing the available data from each national program, the RCC considered the following member states to be at high risk for poliovirus transmission following an importation: Armenia, Azerbaijan, Bosnia and Herzegovina, Georgia, Tajikistan plus the Northern Caucasian region of Russia and the southern and eastern areas of Turkey. The RCC considered that the following countries were at intermediate risk of transmission in the case of an importation of wild poliovirus: Greece, Netherlands, Turkey (remainder of country), Turkmenistan and Uzbekistan.

The RCC extended its gratitude to the outgoing RCC Chairperson, Sir Joseph Smith, who led the Commission from its inception, including the historic June 2002 meeting in which the European Region was declared to be polio-free. Dr. David Salisbury, of the United Kingdom, is the new chair of the RCC.
